# Scope:

The Ofcom Consultation has wide scope, but the focus here is on the following:

- Background
- Power Changes (and EMF/EMC)
- Callsigns incl expiry, recycling
- RSLs
- SES / SSES
- NoV Systems Gateways, Repeater etc

### **Background:**

#### **Current Licence:**

- 400W limit changes based on EMF; and can also be limited in secondary allocations (e.g160m)
- RSLs mandatory but not in ITU Radio Regs/enforceable change is driven by Ofcom legal duties
- RSLs amendments were proposed in 2015 that retreat led to the '#' reset in 2016
- Restricted remote control for Foundation/Intermediate

#### **Outside of Current Licence – NoVs**

- SES automated but too many manual applications
- SSES manual with additional criteria
- SCC largely managed by RSGB, but also dependent on Ofcom expertise
- Beacons, Gateways, Repeaters etc ~1000 NoVs
- Other NoVs include experimental spectrum, PSES, GB2RS newsreaders etc.

#### Notes:

- Call sign policy has never been consulted by Ofcom and had become inconsistent
- Ofcom also has changes to staff and IT and keen to reduce their workload, increase automation

### **Power / Frequency Schedule:**

- Power Changes:
  - Foundation 10W becomes 20W
  - Intermediate 50W becomes 100W
  - Full 400W become 1kW in Primary bands only
  - Note: The EMF threshold is 10Weirp/6mins, so may need to be (re)assessed
- Aeronautical in Primary bands, 0.5W eirp
- No change to 1.8 MHz, 5MHz disappointing feel free to ask!
- Foundation gain 1W low power access to 2.4 & 5GHz
- Definitions for optional suffixes such as /M, /P etc removed, so /xyz is ok

- and Remote Control for Foundation & Intermediate liberalised, but some extra RC conditions









# **Standard Callsigns:**

- Individuals will be single call/licence only (ignoring club or add-ons)
- Lower calls would be expired as you progress from Foundation
- Clubs up to 5 calls to be clarified
- Timing/Recycling: call signs may be resurrected/changed after 2 years!
- Any other period (such as 5 years) will apply to all cases
  - so if you want SK ones to be left longer that timing applies to other cases
- Only post-war 3-letter calls (no more short 2-letter ones)
- Intermediates moving from 2x0 / 2x1 to M8 / M9 to close all 2-Series









# Regional Secondary Locators (RSLs):

- Ofcom proposes they all become optional, but remain fully defined in the licence - see para 4.17 - they are not a legal requirement, so comments need to be on other grounds
- Club RSLs remain optional/defined
- Celebratory RSLs would be enabled by Ofcom web notice, without NoV
- Optional E-usage/equality for all licence classes resolves Intermediate issue if they become M8/9
- Risk even optional RSLs could be swept out by the Ofcom legal team if the wrong fuss is made of them, in line with their minimalist/enforceable approach
- Replies to Ofcom on this topic should be calm/clear/careful e.g. by Nations, avoid new compulsory 'E'
- Some in Ofcom know it's a sensitive topic, but not all
- Not all amateurs favour their mandatory retention - especially new folk, digital/mobile users etc
- If they go optional, could be mitigated by enhanced Operating Practice or Contest Rules
- No Ofcom appetite for new/extra RSLs see risk above









# Special Events - SES / SSES

- Ofcom has long wanted to change this and fully automate applications
- Standard SES already online, but complexity involved with Special-SES
- Ofcom propose a new single longer format based on GBxcccccca
  - More flexible usage, lower time limit, online applications
- Numeric and other based formats out of scope (such as 2MT, 2LO)
- This doesn't prevent some very special ones under an NoV, but that is already less likely









### Beacons, Gateways, Repeaters etc

- Strong push from Ofcom re moving these into main licence to reduce NoVs
- 'QRP' seen as low risk thus a new 5W erp category broader than just gateways
- RSGB coordination/Callsign process retained for >5W erp so little practical change
- Conditions apply! not a free for all, but does need further refinement, catch-alls etc
- Changes include:
  - Compulsory contact marking and closedown time limit clauses in new licence
  - A new 5W repeater category is created, inc for clubs, adhoc usage etc
  - Definitions are spectral to cater for other apps (eg Beacons may cover WSPR, APRS)
