

Foundation overview

If Ofcom confirms its general proposals (if not the finer detail) then Foundation Licensees would be able to:

- Build transmitting equipment more freely than before (but may need safety/spectral guidance)
- Sail out to 12 miles (Territorial waters operation)
- Fly with 0.5W eirp (in Primary allocations only)
- Use more Power 20W rather than 10W (based on EMF adherence)
- Internet remote control (provided it fails safe)
- Use 2.4/5GHz at low power
- Have an open low-power hotspot/gateway (previously closed-mode only)
- Can directly supervise guests

It is not all liberalisation though. A few things have been clarified/tightened to address some previous grey areas

Foundation Callsigns

- No real change to the series in use M3, M6 and M7
- No proposals for a new series
- However old Foundation calls will be cancelled as you progress higher, freeing capacity (notably in the M3 series)

Intermediate overview

If Ofcom confirms its general proposals (if not the finer detail) then Intermediate Licensees would be able to:

- Sail out to 12 miles (Territorial waters operation same as Foundation)
- Fly with 0.5W eirp (in Primary allocations)
- Use more Power 100W rather than 50W (based on EMF adherence)
- Internet remote control (provided it fails safe)
- Can directly supervise guests
- Potentially be a repeater keeper

What isn't changing:

- There are no other changes to the frequency schedule
- The 3-tier system remains Foundation , Intermediate and Full

However:

In contrast to Foundation, Ofcom does propose major changes to Intermediate call signs...

Intermediate call signs

- Ofcom has a legal issue that 2x0 / 2x1 call signs do not fully align with international rules
- Currently this is solved by the compulsory Regional Secondary Locator (RSL) such as 2E1xxx, 2M0xxx
- For consistency, Ofcom proposes a major change to M8xxx and M9xxx replacing the 2-series
- A non-trivial exercise given that there are ~13000 Intermediate call signs in issue

Proposed Changes:

Under the proposals the current 2#0 / 2#1 formats would become M8 / M9

- For new licensees immediately
- For existing licensees optional, based on reserving/mapping the last three letters So: $2E0xyz \rightarrow M8xyz$; $2E1xyx \rightarrow M9xyz$
- For all licensees eventually ending all 2-series
- But don't leave it too late the M8/9 reservation will expire after 3 years, letting anyone else have it

Also:

- Lower level Foundations calls would be cancelled; and likewise your Intermediate call would be if you upgrade to Full
- The prospect of parallel running both 2-series and M8/9 series over an extended period, may be complex
- Ofcom proposals for optional Regional Secondary Locators only apply to M8 & M9, but stay compulsory for legacy 2-Series

Implications and opportunities

Training and Exams:

- As licence changes are extensive, the consequential syllabus changes have to be focused on those affected by Ofcom proposals, to deal with workload and the challenging timeline to update material
- Greater licence freedom and more possibilities can lead to syllabus creep/overload but Exams Group are very aware

Intermediate:

- Intermediate with 100W may reduce some incentives to upgrade to Full
- Better aligns with multimode HF+50MHz equipment
- Intermediates continue to grow as a proportion relative to Full licensees (based on exam pass rates and demographics)

Outreach/Development

- Construction and supervision changes open up extra possibilities, including for public events, Special Event Stations
- A visitor could build a kit and use it on air under direct supervision
- Family/public/ (honoured guests etc) can directly operate under supervision
- New possibilities for Club events/outreach and collaboration, Regional Team enthusiasts etc.
