- If there are any changes to the amount, date or frequency of your Direct Debit Radio Society of Great Britain will notify you 7 working days in advance of your account being debited or as otherwise agreed. If you request Radio Society of Great Britain to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit, by Radio Society of Great Britain or your bank or building society you are entitled to a full and immediate refund of the amount paid from your bank or building society
  - If you receive a refund you are not entitled to, you must pay it back when Radio Society of Great Britain asks you to
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
